Approval Requirements Before Reservation

Harmony Golden Retrievers accepts deposits from approved families. By signing this agreement, Buyer confirms:

- ☐ Buyer has been approved for a puppy or waitlist placement.
- ☐ Buyer has received and reviewed the current Puppy Purchase Agreement and agrees to its terms as a condition of purchasing a puppy.

Purchase Price and Remaining Balance

Standard puppy purchase price: \$3,150

Deposit: \$500

Standard remaining balance after deposit: \$2,650

The remaining balance is due in full at puppy pick-up and must be paid in **cash**, unless a different arrangement is agreed to in writing by Harmony Golden Retrievers. Any additional fee for approved Full AKC Registration is separate from the standard companion-puppy price.

Deposit Policy and Selection Order

- **Non-refundable:** The \$500 deposit is non-refundable if Buyer later decides not to proceed with the purchase.
- **Selection order:** Deposits establish puppy-selection/placement order. A deposit does not guarantee a specific puppy until final selection and placement are completed.
- **Availability:** Sex, color, temperament, litter size, and individual puppy availability cannot be guaranteed.
- **If a puppy becomes unavailable:** If the reserved puppy is determined to have a serious health issue or genetic condition, or otherwise becomes unavailable, the deposit may be refunded in full or transferred to another available puppy or future litter, at Buyer's choice.

AKC Registration

Puppies are sold with **Limited AKC Registration** unless otherwise agreed to in writing. Limited registration means the dog may not be used for breeding purposes.

Full AKC Registration may be available to approved homes and requires an additional fee, completion of the applicable questionnaire, and signing a Full Registration Responsible Breeder Agreement.

Important Acknowledgments

The Puppy Deposit Agreement reserves placement only. The Puppy Purchase Agreement governs the final sale, health terms, veterinary obligations, registration terms, care requirements, rehoming/return provisions, and other responsibilities of Buyer and Seller.

If Buyer does not complete the purchase for reasons not covered by the puppy-unavailability provision above, the deposit is forfeited.
